FRENCH UAEMERS LETTER TO PARLAMENTARIANS ***

UAEM France

UAEM France along with its dialogue partner met with a French Parliamentarian. This parliamentarian defended UAEM France's view vis a vis research transparency in the debate for 2019 law for Funding of Social Security. However, in October 2018, the minister responsible did not agree to our request, saying that such view is unrealistic and render France less attractive for investment.

This letter was aimed to provide our rebuttals to the minister's claim and contribute UAEM's own expertise and show him that UAEM's view is shared by many across borders.

One prime example was the Netherlands which took measures in support of research transparency, so does Italy. In the letter was also an invitation for the parliamentarian to organise a debate and invite the public as well as experts to underline the importance of transparency in research; the letter also contained a request that he scrutinizes France's position to Italy's initiative regarding the WHO.

While the letter has yet to receive any reply, UAEM France is hopeful that the seed contained in the letter will blossom into something remarkable in the future.

NORWAY'S NEW WAY-

Thursday, 14th of March, Aarhus University Campus. Members of UAEM Aarhus, sporting their best 'business casual' outfits met with representatives from three parties from the opposition. Ahead of the Danish parliamentary election, healthcare promises to be one of the top 3 subjects of the election. Thus, the time was ripe to invite candidates to a presentation on the R&D system with focus on the different buttons the state can push in order to tackle the soaring prices on medicines. Armed with delicious snacks (including, but not limited to, fruit), instant coffee and stylish slides, an explosive evening was expected.

Thematically, the emphasis was on the Danish context with Kristoffer Kjærgaard presenting key numbers from the regions of Denmark, highlighting market failure and increasing expenses on hospital medication.

This was followed by an introduction to:

- (1) Health Technology Assessment;
- (2) BeNeLuxA;
- (3) TRIPS-flexibilities and (4) the de-linkage model.

After the presentation, the candidates engaged in a discussion with UAEM members, and an outline of a collaboration on a larger debate on the R&D system took its form. As the participating politicians seemed keen on making prices on medicines a theme in their campaign, the Aarhus chapter will be looking into hosting a large panel debate ahead of the election later in 2019.

GLOBAL HEALTH RANKING'S LATEST MEETING - 1

UAEM Leipzig

From 8th to 10th of February the "Global Health Ranking 2.0" meeting took place in Leipzig. As you know, the Global Health University Ranking, a project by UAEM Europe and the BVMD (the Federal Representation of Medical Students in Germany), is the first systematic survey which examines how the 36 medical faculties at state-funded universities in Germany are involved in research and education on global health issues as well as poverty-associated and neglected diseases and how they ensure that people worldwide have access to the results of publicly funded research.

The aim of the project is to make the area of Global Health, which has been underrepresented in Germany to date, more visible and at the same time to create an incentive for faculties to become more involved in this area.

More about the findings as well as information about the UK, USA and Canada counterparts of the project can be found here.

In the February meeting, there were interesting discussions about the global health approach used in the German global health score card, where Leipzig UAEMers presented their upcoming research project. They analyzed how to implement the decisions that are made and how to adapt these to their further steps. The Leipzig UAEMers are currently working on gaining more internal attention and on recruiting more help from UAEM members in Germany. Possible partners for the launch of the project are bcmd, various STURAs, and the GHA. All in all, the personal meeting enhanced content-related clarification as well as personal commitment of the current team members.
